Building Capacity

Eustace ISD values the partnership of the parents in their children's education. We will promote outreach to all parents so that meaningful involvement and effective partnerships are developed; **together everyone achieves more**. There are many ways families can make significant contributions to student success both at home and by volunteering at the school.

Student achievement is the result of effective home-school-community partnerships. Eustace ISD is committed to the following parental involvement policy:

- An annual meeting will be held to provide parents information concerning the implementation of the Title I program.
- Annually distribute the Parental Involvement Policy, explain opportunities for parental and family participation, and to seek suggestions for improving and strengthening the program.
- Parents will be provided timely information concerning grade level curriculum and goals, expectations
 for school performance, individual state student assessments such as STAAR, STAAR Alt 2, EOC,

 and assessment goals for STAAR and EOC will be provided. Those students that need extra assistance
 will have access to programs that will help them reach these goals.
- Parents will be involved annually in the evaluation/revision of the Title I program, Parental and Family Engagement Policy, and School/Parent Compact using a variety of tools including surveys or questionnaires. The findings will be used to revise the Title I program to meet current needs.
- Parents will be involved in the development, review and evaluation of district and campus improvement plans.
- Parents will have opportunities for learning how to foster improved academic performance for their child(ren).
- Parents will be provided meaningful ongoing communication, such as district website, EISD Update newsletter, Skylert notification, parent conferences, emails, etc., in a language and format appropriate for the communication.

Annual meeting for the Title I Parents and Families

Eustace ISD uses Title I funds to provide school-wide services for all students enrolled at each campus. The Title I campuses will hold at least one meeting annually to review Title I guidelines and services offered at the campus level. Copies of the district's current Parent & Family Engagement Policy and campus designed School-Parent Compact will be distributed at the meeting. Both documents will be provided in English and in Spanish.

The meetings are held during a variety of times to accommodate parent schedules. Notices of the meeting are provided to parents and families through written invitation, public notice and posted on the district website. Translators are available to help with Non-English speaking parents and families as needed.

Parent-Student Compacts

In accordance with Title I regulations, each Eustace ISD campus has developed and will annually update a Parent-Student Compact. This compact provides information regarding how students, parents and families, and staff share responsibility for promoting student achievement. Compacts will be distributed at parent conferences, if possible. The compacts are designed so that both the student and their parents can sign the compact and acknowledge they understand the compact.

Parent and Family Engagement Opportunities

Eustace ISD will build a strong engagement of parents to support a partnership between home and school. The District will, with assistance of its schools, provide assistance to parents of children served by the district, as appropriate, in understanding topics such as the following:

- The state's academic content standards
- The state's student academic achievement standards
- The state and local academic assessments including alternate assessments
- The requirements of Title I
- How to monitor their child's progress
- How to work with educators

Eustace ISD will coordinate and integrate parental engagement strategies under Title I with the following other programs: Preschool programs, Special Education programs, Gifted & Talented Programs, Career & Technology programs, Bilingual/ESL programs and Family Literacy programs.
